In order to be eligible for federal financial aid, males between the ages of 18 through 25 are required to register with the Selective Service System. - I am a noncitizen who first entered the U.S. after I turned 26. Please provide proof of your age and a copy of your immigration document which states when you first entered the U.S.
- I entered the U.S. as a lawful nonimmigrant on a valid visa between the ages of 18-25 years old AND remained in the U.S. on that visa until after my 26th birthday. Please provide a copy of your student visa form I-20 or valid U.S. passport visa stamp with expiration date listed.
- I cannot check any of the boxes above. Please see instructions below.

If you cannot check any of the boxes above, you are required to register with Selective Service.

- If you are under age 26, you can still register with Selective Service at www.sss.gov. Please submit proof of your online registration with this form.
- If you are over age 26, you are not able to register. Therefore, you must complete the following:
 - Write to the Selective Service to obtain a status of information letter addressing your failure to register. You may obtain the Status Information Letter you need to complete online from www.sss.gov. You must submit their mailed response with this form.
 - Provide us with a written statement explaining why you did not register with Selective Service. Be sure to address the following in your statement: where you lived when you were ages 18-25; whether or not you thought you had registered with Selective Service, and why you were not aware of the widely publicized requirement to register when you were age 18-25.
