

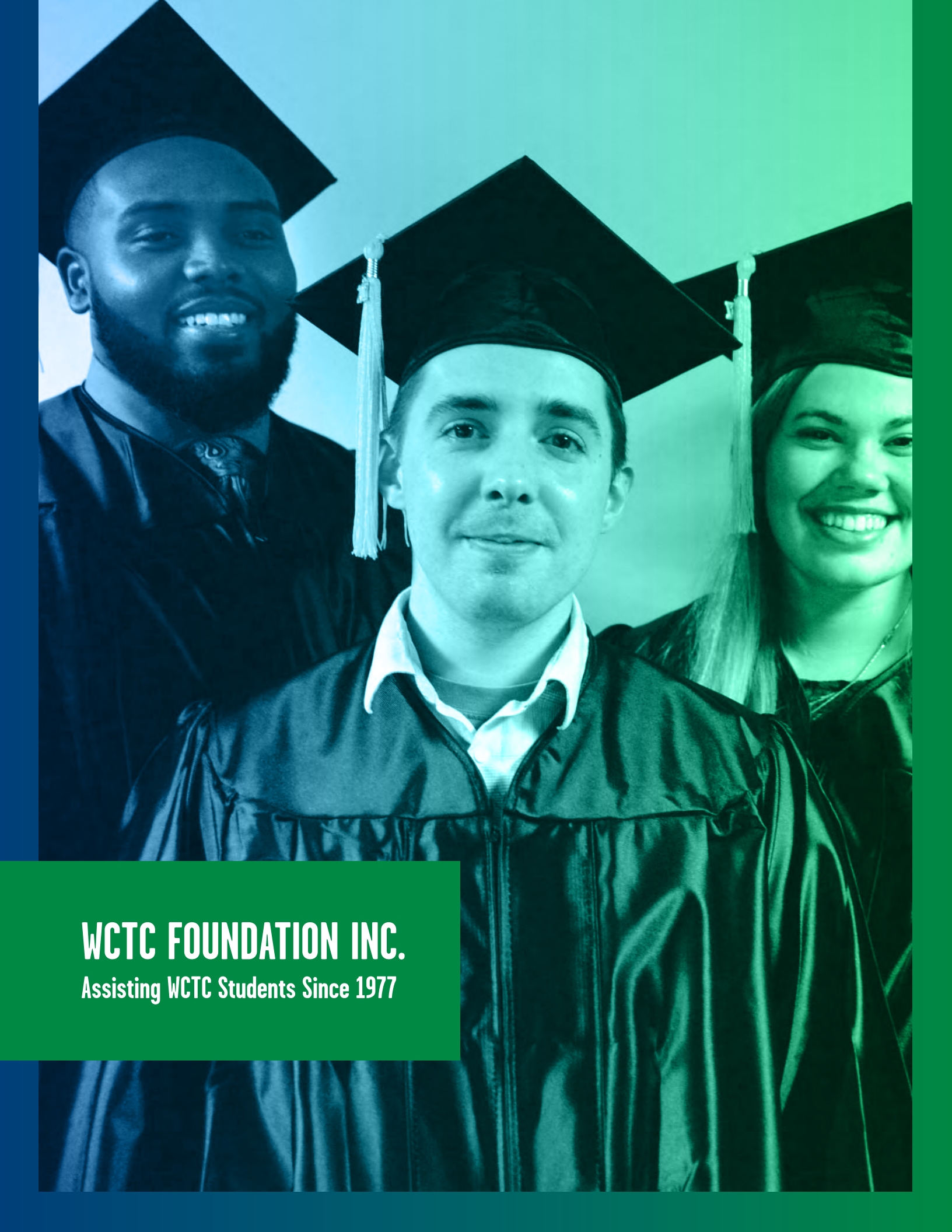

REMEMBERING OUR FRIEND

Ruth Sells, longtime member of the WCTC Foundation Board of Directors, passed away on January 15, 2018, just ten days before her 95th birthday.

Ruth had a longtime interest in education, first serving as President of the Waukesha PTA Council, then appointed to the WCTC Advisory Committee in 1972. Two years later, she was appointed to the Waukesha Area Board for Vocational, Technical and Adult Education, placing her on the WCTC District Board. Ruth served on the WCTC District Board for 14 years and was President from 1984-85. Ruth joined the WCTC Foundation Board in 1988 and served until the time of her death.

Each year the WCTC Foundation selects a person and/or company as its "Partner in Philanthropy." All of these partners are selected based on their generosity and commitment to the WCTC Foundation. In 1997, the WCTC Foundation had the honor of naming Ruth Sells as its partner.

Ruth was also presented with an honorary Associate of Applied Science degree by WCTC in 2012 in recognition of over 40 years of service to the College, the first time WCTC ever awarded such an honorary degree.

The WCTC Foundation is proud to be the steward of the "Oliver and Ruth O. Sells Scholarship." Ruth and her late husband, Ollie, will have their legacy live on through this special scholarship, which assists students enrolled in WCTC's Nursing program.



GORDON HENKE INSPIRATIONAL SCHOLARSHIP

Linda Gordy, Associate Dean, Adult Basic Education, shared the following story:

"When I first came to WCTC, I proposed an additional scholarship from the funds created by the Henke family for two students to complete the Certified Nursing Assistant (CNA) program. This past spring, our first recipient successfully completed the CNA program.

"The student completed High School Equivalency Diploma (HSED) with WCTC a few years ago. She is a single mother with two young girls. She promised her grandmother that she would pursue her dream of becoming a nurse and begin the CNA program.

"The entire process was not easy for her. She needed support and perseverance along the way, but she emailed me that she finished the program and earned a B in the class. Having the CNA license will allow her to get a better paying job and put her on the pathway towards nursing.

"The student would not have been able to start on this pathway without the financial support of the Henke Family. This was a life-changing event for her."



THANK YOU TERRY LUTZ

The WCTC Foundation received a \$2.6 million donation this year from Walter (Terry) Lutz, former Signicast Corporation president and owner, to enhance and expand the College's Integrated Manufacturing Center (IMC). Terry passed away in October 2018, but his generous gifts will impact WCTC students for years to come.

"Manufacturing is crucial to the success of the United States and the American dream. For manufacturing to succeed, it needs employees with skills in tool making, maintenance, machining and welding," said Mr. Lutz. "Technical colleges like WCTC provide students with the skills they need to prosper in manufacturing."

Mr. Lutz held a bachelor's degree in metallurgical engineering, and he hired many WCTC graduates throughout his career with Signicast. He authored the book, *In Pursuit of Manufacturing Excellence: The Signicast Story*, which details how his company was transformed into the largest commercial investment casting company in the U.S.

Mike Shiels, WCTC Dean of Applied Technologies and member of the WCTC Foundation Board, commented that this gift will have "an incredible impact on all of our advanced manufacturing programs," and students will benefit from the new equipment and improvements to the facilities adjacent to the IMC.

The gifts from Mr. Lutz and the Lutz Family Foundation will be used to enhance and expand WCTC's IMC, purchase new training equipment, and fund summer camps and high school teacher training. In recognition of these special contributions, WCTC's IMC and the adjacent building have been named the Terry Lutz Integrated Manufacturing Center. A formal open house and reception was held on May 22, 2018.



QUAD/GRAPHIC SCHOLARS

The WCTC Foundation, along with Quad/Graphics, hosted a reception honoring 20 WCTC students who were recent recipients of the Harry V. Quadracci Scholarship. These students were enrolled in the following programs at WCTC: Graphic Design, Automation Systems Technology, Web and Digital Media Design, Manufacturing Engineering Technology, Mechanical Design Technology, Truck Driving, and Printing & Publishing. Each recipient was presented with a special gift from Quad/Graphics.

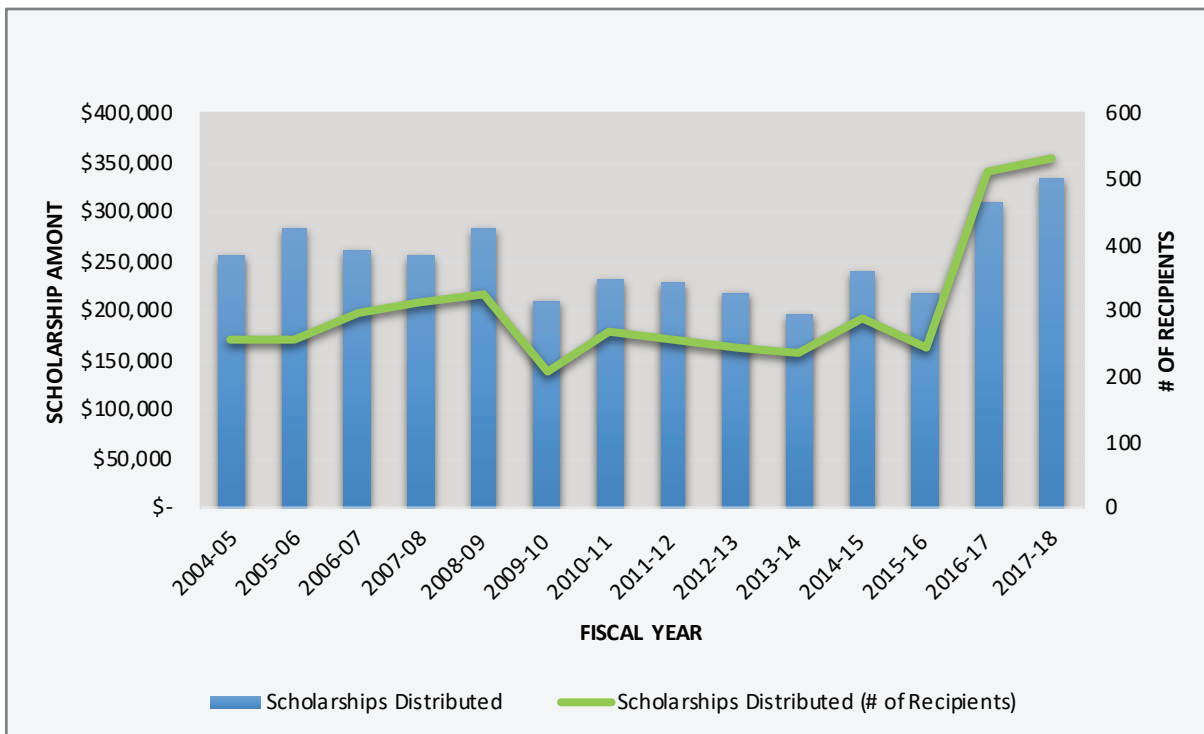
