Expected Responsibilities

Waukesha County Technical College:

1. GM instructor will visit the student and sponsoring employer during the internship experience to review academic progress.
2. Schedule courses in an 8-week format over a 16 week semester as required by General Motors.

WCTC Student:

1. Continuously possess and maintain a valid driver's license for the duration of the GM internship experience.
2. Perform responsible and productive work while maintaining academic/industry standards.
3. Provide required automotive tools at the internship site.
4. Notify sponsor of academic progress and or potential challenges that could affect continued employment, job performance or graduation.
5. Complete and submit the Sponsor Approval Form and the FERPA Internship Release Form to the Associate Dean listed below by October 1st of your first semester in the GM-ASEP program.

Sponsoring Employer:

1. Provide a well-rounded paid 8-week internship (320 hours) experience that corresponds with GM curriculum.
2. Appoint a worksite mentor/coordinator to assign work, maintain communication and oversee the student's progress.
3. Complete a comprehensive student performance evaluation and notify WCTC instructors of any concerns.
4. Representative of sponsoring employer must attend WCTC program advisory committee meetings (2 times annually).

Family Education Rights to Privacy Act (FERPA) Internship Release Form
